The following constitutes Amendment No. 1 ("Amendment No. 1") to the Schedule 13D filed by the undersigned. This Amendment No. 1 amends the Schedule 13D as specifically set forth.

The first paragraph of Item 3 is hereby amended and restated as follows:

The aggregate purchase price of the 786,416 Shares owned by Steel Partners II is \$2,631,130. The Shares owned by Steel Partners II were acquired with partnership funds.

The second paragraph of Item 5(a)-(b) is hereby amended and restated as follows:

As of the close of business on October 15, 2002, Steel Partners II beneficially owned 786,416 Shares, constituting approximately 7.6% of the Shares outstanding. Mr. Lichtenstein beneficially owned 786,416 Shares, constituting approximately 7.6% of the Shares outstanding. Mr. Lichtenstein has sole voting and dispositive power with respect to the 786,416 Shares owned by Steel Partners II by virtue of his authority to vote and dispose of such Shares.

Item 5(c) is hereby amended to add the following:

Schedule B annexed hereto lists all transactions in the Issuer's Shares since the filing of the initial Schedule 13D by the Reporting Persons. All of such transactions were effected in the open market.
